

## Description

The 2-way/2-position solenoid-operated directional seat valves, series WRVE22K..., are NG 5 / SAE 08, two stage, pressure balanced screw-in valves with a 3/4-16 UNF-2A mounting thread. The main and pilot stages are both designed on the poppet/seat principle, and the 2 to 1 flow path is therefore virtually leak-free. This valve type is constructively designed for minimal head loss, thus the flow direction is possible only in one direction (2 to 1). The straightforward design delivers a good price/performance ratio and outstanding head loss/ flow ratings. All external parts of the screw-in val-

ves are zinc-nickel plated, and are thus suitable for use in the harshest operating environments. The slipon coils can be replaced without opening the hydraulic envelope and can be positioned at any angle through 360°. These valves are primarily used as pilot valves in certain mobile and industrial applications where leak-tight shut-off functions are crucially important. Examples are where loads, tensions, or clamping forces must be held without leakage. For self-assembly, please refer to the section related data sheets.




#### NOTE!

measured with oil viscosity 33.0 mm<sup>2</sup>/s (cSt), coil at steady-state temperature and 10 % undervoltage






#### Dimensions and sectional view

The seals are not available individually. The seal kit order number can be found in the chapter "Technical data".




## ATTENTION!
